WHAT WE DO

The Irving K. Barber British Columbia Scholarship Society provides awards and scholarships to students to encourage and facilitate their pursuit of post-secondary education. The Society was created in 2004 following the establishment of a permanent endowment by the Province of British Columbia. The Society is named after philanthropist Irving K. Barber, who was well known for his long-standing support of public education. Since its inception, the Society has granted over \$13 Million in scholarships and awards to hundreds of students across the province. The Society's programs are administered by the Victoria Foundation.

HOW WE DO IT

The Society provides financial awards and scholarships through five separate programs to students attending post secondary institutions throughout B.C. and internationally. These programs help Aboriginal students access post-secondary education, aid students transferring between institutions to complete degrees, and facilitate studies abroad.

Aboriginal Student Award

The BC Aboriginal Student Award improves access to post-secondary education for Aboriginal students by reducing financial barriers. Renewable Awards of \$1,000 - \$2,000 are available for Aboriginal students pursuing trades training, certificates, diplomas, or undergraduate degrees.

Aboriginal Teacher Education Award

This award program, launched in February 2012, supports Aboriginal students enrolled in a teacher education program at a public post-secondary institution in British Columbia. Awards are \$5,000 annually.

Aboriginal Master & Doctoral Award

As a result of a special grant from the Government of British Columbia, the Society has been able to offer awards of \$5,000 each to Aboriginal students pursuing masters and doctoral-level studies. These annually renewable awards encourage completion of post-secondary education at the higher levels and recognize the often high costs associated with obtaining these degrees.

Ike Barber Transfer Scholarship

Ike Barber Transfer Scholarships are awarded to undergraduate students who have completed one or two years of study at a public post-secondary institution and are transferring to another degree granting institution in B.C. to complete their degrees. Scholarships of \$5,000 each are awarded annually from this program.

International Scholarships

The Society's international scholarship programs are for study outside of North America and are available to students enrolled at a B.C. public post-secondary institution. Scholarships of between \$1,000 and \$10,000 are awarded each year to students who have demonstrated outstanding academic achievement and community involvement.

MESSAGE FROM THE CHAIR Rajiv Gandhi





With the help of its namesake, the Irving K. Barber British Columbia Scholarship Society (IKB) was founded in 2005. The Society's singular purpose, like all of Ike Barber's philanthropic endeavours, is to ensure that students - in particular those living in Aboriginal communities and communities far removed from the urban centres of Victoria and Vancouver - are afforded an opportunity to learn, grow, succeed, and contribute to society at large.

Today, IKB serves as steward of five primary endowment funds, through which scholarships and awards are granted to British Columbia students pursuing post-secondary education. Programs are available to fund First Nations, Métis, and Inuit students. Others help students of all backgrounds planning to complete course work abroad, and those whose chosen course

of study requires them to transfer from one institution to another. In 2017, IKB will begin administering a new \$500,000 scholarship fund, established by the Province to encourage women to enter, and hopefully thrive in, British Columbia's burgeoning tech industry.

To the end of 2016, IKB has distributed more than \$13M dollars to thousands of students. More than dollars spent, I dare say the impact on our cities, towns, and families, has been monumental. Students find their own purpose. IKB helps them to achieve it.

It goes without saying that management of a sixty million dollar plus capital fund, divided into several unique academic awards programs is no small feat. It is accomplished only with the assistance of a very talented and dedicated group of professionals at the Victoria Foundation, with whom IKB has had a long standing, and very positive cooperation agreement, and through a body of volunteers from all over the Province who give of their time to evaluate and adjudicate student applications, and to make award recommendations to the eleven directors who serve on the IKB Board.

Irving K. Barber was once described as a visionary, someone with a strong commitment to improving the quality of life in British Columbia. I speak for each of the Society's Directors when I say that it is an absolute privilege to help the students of our province (and beyond) obtain the means by which to achieve their goals.
